VILLAGE OF ISLAND PARK LOCAL LAW NO. 4 OF THE YEAR 1976

A LOCAL LAW REGULATING AUCTIONS AND PUBLIC SALES

I. No auction or public sale shall be held in the Village of Island Park without compliance with the following conditions:

1. An application for a permit must be submitted to the Board of Trustees of the Village in writing at least thirty (30) days prior to the holding of any such sale by the owner or owners of the personal property to be sold.

2. The cost of such permit shall be as prescribed by the Board of Trustees from time to time but in no event less than \$50.00 per day for the holding of an auction sale and \$5.00 per day for the holding of a public sale other than an auction sale, including the day of inspection, if any.

3. No sale shall be held for more than two (2) consecutive days nor shall there be more than one day of inspection. The day or days of sale and/or Inspection shall be limited to the hours from 10 A.M. to 4 P.M.

4. The size and number of signs shall comply with Zoning Ordinance No. 51, Article IV, Section 3 or as otherwise prescribed by the Board of Trustees. They shall not be erected before the date of inspection, If any, or the first day of the sale and, shall be removed by no later than 6 P.14. on the last day of the sale.

5. There shall be no loudspeakers permitted other than a single loudspeaker for purposes of conducting an auction sale and the volume thereof shall not reach beyond the audience.

6. The sale of any property by auction or public sale shall be limited solely to property owned by the resident—applicant.

7. A public sale other than an auction sale on any given premises may be held no more often than twice every year.

8. An auction sale shall be held no more than once by any individual during the period of his ownership of the real property on which the sale Is located.

II. DEFINITION

A public sale shall include sales presently referred to as "garage sales".

III. DISPLAY OF LICENSE

Every licensee conducting any sale hereunder shall keep the Village license displayed in a conspicuous place at the place of sale or on such vehicle used in such business.

IV. VIOLATIONS

Any person violating any provision of this local law shall be subject to a penalty of \$50.00 and In addition thereto, such violation shall constitute and is hereby declared to be disorderly conduct. Any person violating the sane shall be and is hereby declared to be a disorderly person. Each day of any sale not in compliance with this local law shall be considered a separate violation.

V. NON-PROFIT ORGANIZATION EXEMPTION

Nonprofit organizations exempted from taxation under the provisions of the Internal Revenue Code shall be exempted from Section 1, sub—sections 2,3,7,8 and 9 of this local law for the purpose of conducting public sales or auctions at premises owned by such nonprofit organization (s).

VI. VALIDITY

If any clause, sentence, paragraph, section or part of this local law shall be adjudged by any court of competent jurisdiction to be Invalid, such judgment shall not affect, impair or invalidate the remainder of this local law but shall be confined In its operation to the clause, sentence, paragraph, section or part thereof directly involved in the controversy in which such judgment shall have been rendered.

VII. This local law shall take effect Immediately.
