

ORDINANCE NO. 34-b

**DESIGNATING ARTERIAL HIGHWAYS
AND REQUIRING STOPS THEREON**

Section 1

Long Beach Road is hereby designated by the Board of Trustees of the Incorporated Village of Island Park as a main artery of travel at the intersection of Parma Road, Ostend Road, Newport Road, Marina Road, Lorraine Road and Kildare Road in said Village of Island Park.

Sagamore Road is hereby designated by the Board of Trustees of the Incorporated Village of Island Park as a main artery of travel at the intersection of Ostend Road, Parma Road, Radcliffe Road, Quebec Road in said Village of Island Park.

Warwick Road is hereby designated by the Board of Trustees of the Incorporated Village of Island Park as a main artery of travel at the intersection of Radcliffe Road and Quebec Road in said Village of Island Park.

Island Parkway is hereby designated by the Board of Trustees of the Incorporated Village of Island Park as a main artery of travel at the intersection of Radcliffe Road and Quebec Road in said Village of Island Park, Island Parkway, running east and west, is hereby designated by the Board of Trustees of the Incorporated Village of Island Park as a main artery of travel where the same intersects with Island Parkway running northeast and southwest. All vehicles approaching Island Parkway running east and west from Island Parkway running northeast and southwest shall be, before crossing or turning in the same, halted to a full stop unless otherwise directed by a traffic officer or signal. Conspicuous signs or signals shall be displayed at said point. (Amendment added December 20, 1951.)

Nassau Lane is hereby designated by the Board of Trustees of the Incorporated Village of Island Park as a main artery of travel at the intersection of Kildare Road in said Village of Island Park.

Quebec Road is hereby designated by the Board of Trustees of the Incorporated Village of Island Park as a main artery of travel at the intersection of Julian Place in said

village of Island Park.

Section 2

All vehicles approaching any of the main arteries of travel within the village of Island Park as designated by Section 1 of this Ordinance, from an intersecting street, shall, before crossing or turning into the same, come to a full stop unless otherwise directed by a traffic officer or signal.

Section 3

Conspicuous signs or signals shall be displayed at all points where the rule prescribed by this Ordinance is to be observed.

Section 4

Any person violating any of the provisions of this Ordinance, or any part thereof, shall be liable for and forfeit and pay a penalty of not more than \$25.00 for each violation, thereof for the use of said Village. Any violation of any provisions of this Ordinance, or any part thereof, shall constitute disorderly conduct, and any person violating any provision of this ordinance, or any part thereof, shall be and is hereby declared a disorderly person.
