

ORDINANCE NO. 11

**REMOVAL OF SNOW, ICE, WEEDS, ETC.
FROM SIDEWALKS AND ASSESSMENT OF EXPENSE FOR SAME.**

Section 1 It shall be the duty of every owner, lessee, occupant or the agent thereof of any one family dwelling and of every owner or agent thereof of any other building and of every owner or person entitled to possession or the agent thereof of any vacant lot or lots and of every person having charge of any church, school or other public building in the Village of Island Park during the winter season and during the time the snow shall continue on the ground, to keep the sidewalks in front of or adjacent to such house, building, lot or lots free from obstruction by snow or ice.

Section 2 No such person shall cause, suffer or allow any snow or ice to collect and remain on any sidewalk fronting on or adjacent to such house, building lot or lots, so as to impede, obstruct or render difficult or dangerous public travel upon such sidewalk later than ten o'clock in the forenoon of the day following the day the same shall have fallen or collected thereon, but in no event later than twenty-four hours after the same shall have fallen or collected thereon, or for more than two hours after being notified by an officer of said Village or a duly delegated agent thereof.

Section 3 It shall be the duty of every person herein before specified in Section 1 hereof at all times to keep such sidewalk in good and safe repair and clean and free from dirt, filth, weeds and any other obstruction, encumbrance or substance, and no such person shall cause, suffer or allow a condition to the contrary to exist.

Section 4 If the provisions of the foregoing sections or of any of them, are not complied within the time prescribed therein, the Board of Trustees, or its agent, may cause such snow, ice, dirt, filth, weeds or any other obstruction to be removed from said sidewalks and the actual cost of such removal and other costs incidental to such removal shall be certified by the Village Clerk to the Board of Trustees, and the amount so certified shall thereto be assessed and levied on such land, and the same shall be collected and enforced in the same manner as taxes.

Section 5 Any person or persons, firm, association or corporation, violating any provision of this Ordinance, or any part thereof, shall be liable for and forfeit

and pay a penalty of not less than Ten (\$10) Dollars nor more than Twenty-Five (\$25) Dollars for each violation thereof for the use of said Village. Any violation of this ordinance, or any part thereof, shall constitute disorderly conduct, and any person violating any provision of this Ordinance, or any part thereof, shall be and is hereby declared a disorderly person. The act of the Board of Trustees in assessing any levying the costs of removal against the land adjacent to such sidewalk, pursuant to Section 4 hereof, may be in addition to and in conjunction with the penalty prescribed by this Section and shall not bar or prevent further action under this Section.
